Mexico presents its initial Report on the implementation of the United Nations Convention on the Rights of Persons with Disabilities.

In compliance with international obligations and as a reaffirmation of their commitment to the promotion and protection of the rights of disabled persons, the Mexican government presented the UN with their first report on the implementation of the United Nations Convention on the Rights of Persons with Disabilities, an instrument ratified in our country on December 17th, 2007.

The report was carried out using information supplied by the 55 departments of the Federal Executive

as well as contributions from the Legislative and Legal Powers, and 17 entities of the Republic, the National Human Rights Commission, the Federal District Commission of Human Rights and academic institutions.

COMPLAINT REGARDING MEXICANS ON TRIAL IN MALAYSIA

The National Human Rights Commission informs that it received a complaint from the relatives of the three Mexican citizens that are on trial in Malaysia and that could be condemned to death by hanging.

The complaint highlights an alleged lack of

attention from Mexican authorities.

The national Institution shall request information on the case from the Foreign Ministry in order to discover the action taken by Mexican authorities.

The relatives shall receive the corresponding support, advice and accompaniment. After the analysis and the evaluation of the evidence, the CNDH shall issue the resolution in accordance with the law.

MORE THAN FIVE THOUSAND PEOPLE REPORTED AS MISSING

April 2nd, 2011

The National Human Rights Commission registered five thousand 397 files on persons reported as lost or missing from 2006 to 2011.

Through the National Information System

for Missing or Unidentified Deceased Persons (SINPEF) the CNDH compiles the data provided by family members of people reported as missing and offers them guidance.

Additionally, it holds information of eight thousand 898 dead people that have not been identified by the corresponding authorities.

The National Commission has begun to integrate data on migrants whose location is unknown into the Information System, to search for and locate them.

ARBITRARY DETENTION AND INTIMIDATION OF VISITOR

The National Human Rights Commission expresses its utmost protest against the intimidation and arbitrary detention that one of its assigned visitors was subject to in Tijuana, Baja California, when carrying out their job to protect a migrant that had been repatriated to the United States minutes before.

The visitor was taken before a qualifying judge and was detained for around three hours. The CNDH presented a legal complaint against the mentioned police officers who are responsible for the intimidation and arbitrary detention of the official.

He added that it is necessary to channel the promotional initiatives of the Culture of Legality and the duties of persons towards the 32 million children between 0 and 14 years of age that populate the country.

A fundamental strategy is the incorporation of the teaching of human rights in primary education, as it is proposed in the constitutional reform.

INVESTIGATION AND PRECAUTIONARY MEASURES IN TAMAULIPAS CASE

The National Human Rights Commission filed an official complaint and is investigating the alleged homicide of persons found in the municipal district of San Fernando, in the state of Tamaulipas.

It requested precautionary

measures from the Attorney General's Office and the entity's District Attorney's Office for the preservation of evidence in order to guarantee the identification of bodies.

It exhorts the three levels of government to carry out hasty and efficient investigation and procurement and delivery of justice. The CNDH reiterates its concern for the constant violations of the right to public safety; a right which must be guaranteed to all people within national territory.

CNDH forensic doctors spoke with specialists

of the International Committee of the Red Cross (CICR).

In the meeting they agreed that said instrument will allow advances in the identification of bodies and in this way will help to prevent the bodies being placed in communal graves.

Present at the meeting were specialists Karl Mattli,

the regional representative of the International Committee of the Red Cross, Doctor Morris Tidball-Binz, global coordinator of the institution and Doctor Alejandra Jiménez, consultant of the CICR regarding the matter.

INAPPROPRIATE ACTION OF CIVIL SERVANT

The National Human Rights Commission issued the Recommendation 11/2011 directed to the LIX Legislature of the Congress of Guerrero and the town council of Metlatónoc in this entity regarding the action of a civil servant that, without the owner's authorization, nor that of a competent authority, the police of Juanacatlán, of the municipal district of Metlatónoc, entered the area and using heavy machinery knocked down a water tank in an attack against a citizen that had not agreed to take care of the church belonging to the area.

The National Commission launched investigations into the case and observed

that the human rights to legality, legal security and freedom of speech of the offended were affected, by acts attributable to the municipal police force.

OMBUD\$MAN PRE\$ENT\$ COMPLAINT BEFORE PGR

Raúl Plascencia Villanueva, president of the National Human Rights Commission formally presented a complaint before the Attorney General's Office (PGR), due to the intimidation and arbitrary detention to which one of the assigned visitors was subject on March 30th, in Tijuana, Baja California when carrying out his job protecting a migrant.

The national Ombudsman went accompanied by the five general visitors of the CNDH, who were welcomed by the state's attorney Marisela Morales Ibáñez.

Plascencia Villanueva stated that "it is very worrying that attacks such as these are made against CNDH staff without any justification and simply for doing our job a human rights defender is deprived of their freedom."

CNDH RESOURCE PROSPERS IN SCIN

April 14th, 2011

Upon resolving the unconstitutionality act 48/2008 put forward by the CNDH, the Supreme Court of Justice of the Nation declared invalidity on several counts, regarding criteria that will benefit naturalised Mexicans and Mexicans with double nationality.

It was declared unconstitutional that naturalised Mexican citizens be prohibited from taking operative posts in the Federal Police (PF) and the Attorney General's Office (PGR).

Said roles are those of Federal Police officers and in the PGR, those of Public Prosecutor's Office of the Federation (MPF) officers, and in the Ministerial Federal Police (PFM), ministerial officer and career expert. It also invalidated the requisite of not possessing double nationality applicable to PF and PFM officers.

It is the first time in our country that a human rights protection Institution has achieved the declaration of invalidation of several legal norms that violate human rights.

REFORM TO HUMAN RIGHTS EXAMPLE FOR LATIN AMERICA

Raúl Plascencia Villanueva, president of the CNDH stated that the constitutional reform for the defence and promotion of human rights represents one of the most important advances in our country's legal system and that it is an example to be followed by Latin American nations.

He also pointed out that it opens up the possibility of those authorities that don't accept or comply with the recommendations issued by human rights public institutions finding themselves obliged to establish, promote and make public their refusal before the corresponding legislative authority.

This took place during

his participation in the Forum on the Analysis of Sentences issued by the Inter-America Court of Human Rights, in the state of Coahuila.

3 OUT OF 10 SUFFER BULLYING IN PRIMARY SCHOOLS

Given the risk to 18 million 781 thousand 875 primary and secondary school students of suffering the phenomenon known as bullying or school harassment, it is indispensable to reinforce action to eradicate this damaging practice. It is estimated that in Mexico three out of every ten primary school students have received some form of physical attack from a peer.

This situation is worsened by cyber-bullying, a mode of harassment in which young people are threatened, insulted or ridiculed in videos that circulate the internet and social networks. To combat the problem the CNDH has trained primary, secondary and higher education students, teachers and administrative staff in the importance of respecting human rights.

The national Ombudsman informed that he has held meetings with authorities involved in the situation, academics, civil society organizations, business people, labourers

and citizens interested in contributing to t he search for solutions.

He also endorsed the commitment of the National Commission in the monitoring of all action that contributes to resolving the situation suffered by the residents of Ciudad Juárez.

CNDH IDENTIFIES DANGER ZONES FOR MIGRANTS

April 18th, 2011

The National Human Rights Commission specified the places where there is a risk of becoming a victim of crime in the Special Report on Migrant Kidnapping Cases in Mexico.

These points are located in Baja California, Chiapas, Coahuila, Estado de México, Guanajuato, Guerrero, Michoacán, Nuevo León, Oaxaca, Querétaro, Quintana Roo, San Luis Potosí, Sonora, Tabasco, Tamaulipas and Veracruz. 71 municipal districts are mentioned to have road ways and rail ways where in some zones kidnappings, maltreatment, extortion, theft and sexual attacks on migrants have been reported.

In response to this situation, the CNDH calls upon the Mexican authorities to effectively guarantee the right to public safety at points of meeting and travel of Mexican and foreign migrants, in order to avoid events such as those that took place in San Fernando, Tamaulipas.

ATTACK AGAINST CHILDREN AT POLICE POST

The National Human Rights Commission is investigating the events that took place in Ciudad Cuauhtémoc, Chihuahua, where two children that passed a police post were attacked and one ended up with serious injuries. Around 21:00 hours, friday april 8th, local and federal authorities at a police post located on the motorway Cuauhtémoc-Chihuahua, opened fire on the children when supposedly they ignored instructions to stop.

Once the complaint file has been implemented and the analysis and evaluation of the collection of evidence are concluded the CNDH shall issue the corresponding resolution in accordance with the law.

SERVANTS IN OAXACA FAIL TO COMPLY WITH MUNICIPAL MANDATE

April 21st, 2011

The National Human Rights Commission issued the Recommendation 17/2011, directed to the Congress of Oaxaca and the City Hall of Huajuapan de León, regarding the case in which two individuals closed off sections of their own land with wire fencing. Additionally, however, they invaded public access and obstructed the entrance to the housing condominium

San Isidro of this locality.

The CNDH launched an investigation after the inhabitants of the condominium filed recourse to impugnation due to the failure of both the municipal president and the Syndicate to comply with an agreement issued in a local government session.

The agreement was to remove the fence and reinstall free access to the condominium.

The national Institution observed that this negligence represented the violation of the human rights to legality, legal security, petition and free transit, to the detriment of the affected neighbours.

The CNDH compiled 144 human rights instruments that are available to the public as a way of promoting discovery of their content and potential.

Included are documents that protect the rights people possess around the world, regardless of their situation or circumstances and are available for consultation by any interested party.

Using a basic search engine one can find binding (obligatory), non-binding (non-obligatory or for declaration), regional and world classified files, and therefore facilitating revision of them.

The legislative reform recently approved by the Congress highlights that the CNDH will be able to exercise unconstitutionality action when a law violates the human rights granted in the Magna Carta and in the international agreements.

For this reason, the Institution is carrying out a National Programme to tackle it.

Attacks can occur between children, can be from teachers to students, from students to teachers and from parents to teachers and students.

With the National Programme to Abolish and Eliminate Violence in Schools the National Commission aims to prevent damages to the teaching process as well as psychological problems.

UNJUST EVICTION IN OAXACA

The National Human Rights Commission issued the Recommendation 20/2011 directed to the Congress of Oaxaca and the City Hall of San Pedro Pochutla in this entity regarding the case of a citizen that was evicted from his land by the state attorney representative, the police commanding officer and several municipal police officers, on the grounds that it was a decision taken by the general assembly of commoners.

Whilst maneuvering the removal several of the victim's belongings were destroyed. The National Commission investigated the case and noted that his human rights to legality, legal security and property were violated by acts attributable to the earlier mentioned officials and

The National Human Rights Commission informs that from the collection of evidence that compile the complaint file CNDH/2/2009/4988/Q the national institution was able to observe that civil servants of the 18th Infantry **Battalion of the National** Secretary of Defence as well as Tabasco state attorney's office civil servants violated the human rights to integrity, personal safety, non-violation of the home, legality and legal security to the detriment of V1 and V2, due to constant

acts of arbitrary arrest, violation of the home, illegal detaining, illegitimate use of public force, cruel treatment and torture, which led to the Recommendation 14/2011.

to the issuing of Recommendation 15/2011.

The CNDH informs that from the collection of evidence that compile file CNDH/1/2010/4452/Q, in terms of what article 14 of the Mexican Human Rights Commission Law sets out, they discovered elements that prove violations to the rights to personal integrity and safety, as well as legal security, repeated incompliance of persecutory role, access to justice and safeguard of rights that as a victim of crime are recognized

by the Mexican legal system to the detriment of V1.

Such violations are imputable to the Federal Secretary of Public Safety, as well as the Attorney General's Office and the Nuevo León state attorney's office, which led to Recommendation 16/2011.

Such rights are recognised in articles 8, 11 and 14, second paragraph, and 16, first paragraph of the Political Constitution of the Mexican United States. Said acts are attributable to AR1, AR2 and AR3, therefore the Municipal President, the First Syndic and the Director of Urban Development of the City Hall of Huajuapan de León, Oaxaca, which led to Recommendation 18/2011.

This was through the unjust exercise of authority that they had been assigned, derived from an illegitimate use of force and firearms.

Additionally, they violated these persons' rights to legality and legal security granted by articles 1, second paragraph, 16, first paragraph and 21, first paragraph of the Political Constitution of the Mexican United States, which led to the issuing of Recommendation 22/2011.

integrity, occurred to the detriment of V1, V3, V4, V5, V6, V7 and V8, due to repeated acts of improper exercise of civil service. Additionally, the rights to legality and legal security of V2 were violated, which led to Recommendation 23/2011.
