To achieve full applicability and respect for the Human Rights of Children and Adolescents is one of the main challenges for authorities and society, the National Ombudsman emphasizes.

Mexico City, September 3rd, 2015

The National Ombudsman, Luis Raúl González Pérez, noted that the General Law on the Rights of Children and Adolescents is a minimum platform to realize and fulfill their rights. He also said that this legal instrument, serves as a basis for the development of a coherent and ordered system of laws, procedures and agencies to achieve this.

The biggest challenge this imposes, he highlighted, is to implement or realize the provisions of the Act, that is, to achieve that what is provided in the norm is reflected in everyday reality.

González Pérez was accompanied at the presidium during the opening ceremony of the National Forum "The Role of Public Organisms before the General Law on Children and Adolescents", by the Director of the Institute for Judicial Research of UNAM, Pedro Salazar Ugarte, and Isabel Crowley, UNICEF Representative in Mexico. The event was also attended by the 32 heads or representatives of the Human Rights Institutions in the country.

The National Ombudsman pointed out the urgent need of attending some pending issues that condition and determines the effective implementation of the law, such as the issuance of Regulations of the same Act, as the creation and establishment of a decentralized administrative agency that should operate from the Executive Secretariat of the National System for Integral Protection.

He explained that the task is not simple, due to the extensive, diverse and complex contents of the Act. These contents cover theoretical and conceptual aspects, as well as others influencing policy fields such as civil, telecommunications, health, education, organizational, operative, procedural and sanctioning aspects. He added that it also sets parameters and guidelines for public administration.

He noted the need to generate the conditions to achieve universal and equitable access for all children and adolescents of their rights. "Today, one of the most serious expressions of inequality and exclusion existing in our country is reflected in our childhood, especially in the most disadvantaged sectors of our society, those living in poverty," he said.

Acknowledging the progress and efforts made by the Mexican State in the matter, he highlighted that it should not be forgotten the great number of girls and boys that live every day in our country with malnutrition. They also lack of basic services and health, education, they suffer violence, uncertainty, labor exploitation, and lack of basic aspects such as the way to accredit and maintain their identity.

Finally, he pointed out that this forum co- organized by the National Human Rights Commission (CNDH) and UNAM's Legal Institute, aims to generate inputs that contribute that Public Agencies for Human Rights defense and protection undertake in a better way what is provided by the General Law of Children and Adolescents. Also the forum aims, to bring to the public attention the need for both, authorities and society, to assume the rights of children and adolescents as one of our priority tasks.

CNDH ENCOURAGES THE INCORPORATION OF GENDER PERSPECTI-VE IN PUBLIC POLICIES THAT TAKES INTO ACCOUNT THE NEEDS OF INDIGENOUS WOMEN IN THE COUNTRY.

The National Human Rights Commission (CNDH) reaffirms its ongoing commitment to the effective protection in the rights of indigenous women in our country. That is why; it promotes that the gender perspective should be included in the design of public policies for this population sector, taking into account their needs and adopting a comprehensive vision that addresses all aspects that affect them directly.

On the occasion of the International Day of Indigenous Women (September 5th), CNDH recognizes that the situation of our indigenous women is complex, as they face a triple historical discrimination based on their gender, their poverty and the population group where they belong.

CNDH acts as a link between society and public staff to promote respect for human rights, including those of indigenous people and communities, with special emphasis on women, whose rights are susceptible to be violated due to their vulnerable condition.

The National Commission hears complaints and disagreements for violations of indigenous women's human rights. It also, promotes and disseminates human rights through talks, seminars, workshops, forums, conferences, distribution of material, among other activities, aiming to consolidate a culture of respect for fundamental rights in that sector of the population.

On the occasion of this commemorative date, the National Commission gave in San Felipe del Progreso, Mexico's state, a specialized conference on indigenous women rights, in coordination with the National Commission for the Development of Indigenous People (CDI), to promote and give greater recognition to women belonging to Mazahua community, besides providing them with tools that claim and enforce their rights.

The National Human Rights Commission (CNDH) welcomes the "Ayotzinapa Report: research, initial conclusions on disappearances and murders of Ayotzinapa students", presented last Sunday, September 6th by the interdisciplinary working group of independent experts from the Inter- American Commission on Human Rights (GIEI). This report, in its public version, has been included to the file integrated by this National Organism, in order to analyze it.

GIEI report presents many similarities with the document "Research status on Iguala Investigation Case", presented by CNDH

last July, making clear the need to become effective on the issue rights to truth, justice, the integral reparation to the victims and the non-repetition, which have been factors that have guided the investigation into this case carried out by the National Commission in the field of human rights.

The relevance and importance of the case claim that all related investigations with the case, should be carried out in an impartial comprehensive, integral and meticulous manner, supported by evidence and rigorous scientific criteria, in order that pronouncements given at its time, allow to know the truth, encourage ac-

countability for those responsible of their actions, as punishment and justice according to law. The above, in order to prevent impunity and that victims 'rights are violated. Tests and evidence to support the findings of the research will be the only way to know the truth about this case.

CNDH, through the Special Office for the "case Iguala", as part of the research, will continue interacting with the GIEI purposes of dialogue and exchange of information and views on the case.

HUMAN RIGHTS GO BEYOND STATES AND ARE POSITIONED AT IN-TERNATIONAL SCOPE: THE NATIONAL OMBUDSMAN

Today human rights go beyond States and have to be seen in the international context, the President of the National Human Rights Commission, Luis Raúl González Pérez, stressed.

For this reason, CNDH signed two Collaboration Agreements, in separate events, with the Inter-American Human Rights Commission (CIDH) and the Inter-American Court of Human Rights.

The National Ombudsman noted that this collaboration with international organizations will allows proposing as an axis the sum of efforts in complex situations for the exercise of fundamental rights. It's about, he said, to create working models based on international cooperation and collaboration in support of human rights at the regional level.

During the signing of the collaboration agreement with CIDH, the National Ombudsman noted that the National Commission will use all its powers and duties in favor of the victims, so they can make possible their desire for justice and equity.

Moreover, James L Cavallaro, First Vice- Chair of the Inter-American Commission on Human Rights (CIDH), noted that the Inter-American subject, in order to be

efficient and effective, has to be more than the bodies themselves, namely, "The American Commission and Court should find ways to work with important and recognized institutions for their labor on behalf of human rights, such as CNDH"

Furthermore, the Chairman of the Inter-American Court, Humberto Antonio Sierra Porto, highlighted that the Mexican State has a great responsibility, due to its leadership in Latin America.

The National Human Rights Commission (CNDH) deplores the events in Egypt that killed Mexican tourists and their native guides. At the same time it sympathizes with their relatives and requires Mexican diplomatic authorities to continue the actions undertaken to fully clarify the facts and support those who remain hospitalized and their families in our country.

This National Organism underlines the importance that diplomatic authorities of our country, keep their actions in favor of both, those who were deprived of fundamental rights, such as life, and those who were injured, in order to achieve, according to international standards, the clarification of the facts, access to justice, that there is no impunity and the reparation of the damage.

CNDH asked the Foreign Ministry to maintain contact with diplomatic representatives of Egypt in our country, in order to raise all information that helps determine the truth of these unfortunate events.

The National Commission underlined the responsibility of any democratic State to ensure public safety of all individuals located in

its territory, without distinction, noting that force and violence is never the way for conflict and differences resolution.



INTERNATIONAL JUSTICE IS NEEDED FOR PERMANENT PEACE

September 22nd, 2015

In 2014, there was a lot of reflection on the First World War (1914-1918), which actually was a largely European war, but with significant implications for the last century. The League of Nations of the American president, Woodrow Wilson (1913-1921), failed to secure the conditions for lasting peace. With time perspective, the essay of John Maynard Keynes about economic consequences of peace resulted into a considerably warning.

After three decades of regression, we must re-engage with the most inclusive and equal ethic of the Declaration of Philadelphia, the conference of Bretton Woods and Marshall Plan, with a New Global New Deal for our times.

This 2015, attention was attracted by the end of Second World War (1939-1945), seven decades ago. The gradual disappearance of most of the colonial

empires in the subsequent three decades after the conflict, promised a new era for international justice.
