

THE CNDH WELCOMES AND RECOGNIZES THE COMPLAINT ISSUED BY THE MEXICAN DELEGATION BEFORE THE UN AGAINST THE SPEECH FULL OF HATE, AND IT ENDORSES ITS COMMITMENT WITH MIGRANT PEOPLE TO MAKE EFFECTIVE THEIR RIGHTS IN ORDER FOR THEM TO PREVENT BEING VICTIMS OF RACISM AND DISCRIMINATION

The National Human Rights Commission (CNDH) welcomed the warning and complaint presented by the Mexican Delegation before the United Nations, in the context of a discussion about the speech of hate. This speech, as the Undersecretary for Multilateral Affairs and Human Rights before the Human Rights Council said last march 8 "pretend to criminalize people in migration context, and encourage racism and xenophobia". This also took part in a moment in which the UN state members will adopt a global agreement on migration in 2018.

In this sense, the CNDH supported the undertaken actions that favor the people who is in a migratory situation, and reaffirmed its commitment with individual's dignity defense. It also remembered that among the assumed actions that would take into account, according to the content consulted between the CNDH and the United Nations

High Commissioner for Human Rights, they will be in coordination with it and from their respective competence scopes. This will tend to revert the increasing damaging situation faced by Mexican migrants in the United States, for what they will raise their voices ever more loudly in order to reject the serious risk that entails the speech of hate against those persons and that is appearing with more frequency.

In this regard, this National Organism underlines that it has intensified its tasks linked with the Mexican consular network located in the United States and that favors Mexican people in migration context. The above aims to protect their human rights, and for them to be enforceable in the United States. This will also help to prevent that people who is on a migratory situation should not be victim of discriminatory, homophobic or xenophobic acts.

The global agreement on mi-

gration, will initiate this month a consultation process, and will be followed by a balance phase. The text will be agreed between February and July of 2018 and will be called "Global Compact for a secure, regular and orderly migration". It should be accompanied by an International Agreement on refugees, looking forward for the member states to make more explicit commitments for their protection.

The CNDH participated at the panel "Factors that contribute to the climate of violence", in the context of the 30th General Assembly of Global Alliance of the National Human Rights Institutions (GANHRI), held in Geneva, Switzerland. In this event, it highlighted that the major risk that the national institutions and organisms on human rights defense face, is the resurgence of the speech of hate that puts in risk the human dignity and the human rights. In this sense, the CNDH commented that it has published a public opinion web site: migrantes.cndh.org.mx anyone can find information and orientation and our conational could be orientated so they can protect their human rights. It finally underlined that in this area, the National Human Rights Institutions also play an important role to achieve the Global Compact objectives.

THE CNDH, CIVIL ORGANIZATIONS AS WELL AS THE FEDERAL, STATE AND MUNICIPAL AUTHORITIES AGREED TO STRENGHTEN THE VIGILANCE AT THE COATZACOALCOSACAYUCAN CORRIDOR, IN ORDER TO PREVENT KIDNAPKING AND ATTACKS AGAINST MIGRANTS

April 17th, 2017

The National Human Rights Commission (CNDH), civil organizations, as well as federal, state and municipal authorities agreed to strengthen the vigilance at the Coatzacoalcos-Acayucan by the Public Security authorities. Likewise, they agreed on incrementing the watchfulness on several shelters that provide care to individuals in migration context, before kidnaping actions, extortion and injuries occurred since October of the last year. The aforementioned, resulted from an encounter proposed by the CNDH in which it give a special follow up to some recent facts occurred such as the kidnapping of seven Hondurans: one escaped and the others resulted injured and extorted.

The meeting was held at the CNDH's Foreign Office of the port of Veracruz and was led by Edgar Corzo Sosa, Fifth General Visitor and Jesús Quintana Roldán, General Director of the Protection Program to Migrant Persons. In the meeting participated representatives of the Public Security Ministry, of the National Migration Institute, of the Federal Police, of the Regional Prosecutor's Office of Veracruz, of the State Human Rights Commission (CEDH), of the State Police, of the General Direction of Attention to Migrant People of the state, of Minatitlan City Council, of Las CHOPAS, of Coatzacoalcos and Acoyucan. There were also people from the OSC Mesoamerican Migrant Movement and Las Patronas, besides shelters, food centers La Esperanza del Migrante, Decanal Guadalupano, Casa de la Caridad de la Diócesis de San Andrés Tuxtal and Emanuel.

THE CNDH, ACADEMIC INSTITUTIONS AND ORGANIZATIONS OF THE CIVIL SOCIETY, PARTICIPATED AT THE FRAMEWORK OF THE HEARING CORRESPONDING TO THE 57TH EXTRAORDINARY PERIOD SESSIONS OF THE INTERAMERICAN HUMAN RIGHTS COURT IN THE CITY OF GUATEMALA

April 1st. 2017 DGC/096/17

On the last march 22nd, the National Human Rights Commission (CNDH), participated at the public hearing before the Inter-American Court of Human Rights. The purpose of the hearing was to expose before the regional court the different approaches contained in the written amicus curiae that was presented the last January 19, 2017. The document was discussed in the context of the advisory opinion approach requested by the Colombian Republic in March 14, 2016, and under the 57th Extraordinary Period Sessions of the Inter-American Court that was celebrated in Guatemala City from March 20 to March 25 of 2017.

In the appeal made by the Colombian State, which requested to the American Court the clarification of the prevailing relation between the establishment of regimes of the environmental protection within transnational scope (mainly as regards marine environment) and the enjoyment and enforcement of human rights, as well as the exercise to life and personal integrity. The Colombian state also demanded to the court to stablish other issues as the Pact of San José jurisdiction within these regimens, as the conditions that the environmental impact studies must accomplished inside the aforementioned protection areas, in order to protect the above pointed out human rights.

The CNDH highlighted that the Inter-American Court of Human Rights needs to recognize the environment protection and to ensure that this topic corresponds by itself a human rights matter.

THE CNDH CALLS UPON SOCIETY AND AUTHORITIES TO BRAKE THE BARRIERS THAT LIMITS THE INTEGRATION OF PEOPLE WITH AUTISM

April 2nd: "World Autism Awareness Day"

Worldwide, people with autism face serious barriers. The mainly barriers they face are because of attitudes, but they are so many such as: not finding a timely diagnosis, limited opportunities, appropriate medicines, education of quality, care services for their effective integration, as free open and accessible work. According to data published by different international studies, more than 80% of the adults that suffers autism does not have access to employment. According with data published by the National Institute of Statistics and Geography, in Mexico there are approximately 46,000 people that live with autism.

For that reason in December 18 of 2007, the United Nations approved General Assembly unanimously the Resolution A/ RES/62/139 in order to celebrate each April 2 the World Autism Awareness Day. This day has as commitment to raise awareness upon the need to adopt measures in order for girl, boys, youngsters and adults with autism to access better opportunities and to an autonomous and independent life with their community.

In this context, the National Human Rights Commission calls authorities of different government levels, likewise society toge-



ther, to transcend to a medical-rehabilitation focus-aiming people with autism in Mexico to get access to appropriate and a sufficient support system, in order to ensure equal opportunities of all kind, with absolute compliance and respect to their human rights.

THE CNDH WARNS UPON THE SPEECH OF HATE THAT IS ARISING, MAINLY IN THE UNITED STATES, DEGRADES, INTIMATES, PROMOTES THE PREJUDICE AND INCITES TO VIOLENCE

The National Human Rights (CNDH) Commission about the seriousness upon the speech of hate that is arising after two worldwide wars and a shameless genocide occurred during the XXI century. The speech is arising with renewal rhetoric and humiliates, intimidates, promotes prejudices and encourages to violence against people and groups, not only because of race but also for economic and sexual preferences, for cultural differences based on nationality, social and economic condition as sexual preferences or religious beliefs.

To this National Organism, the actual hatred transgressor speech is worst with the groups, which are in the most vulnerable ABRIL

situation such as migrants and refugees. The aforementioned is because there are cases, from the highest power spheres, in which an extreme violent rejection against them has been promoted, such as occurs in the United States of America, where intrinsic dignity and equal and inalienable rights recognition have been put in risk.

In occasion of the commemoration of the International Day of Reflection on the Genocide in Rwanda –April 7- the CNDH highlights that from a human rights

perspective, we all have learned that prejudice brings discrimination. He also have learned that discrimination leads to prosecution and it to extermination. For this reason, we cannot go back to the past, nor must we allow the hatred speech to gain ground, based upon new migratory policies and a supposed exercise of freedom or public liberties.

THE CNDH WARNS UPON THE NEED TO INDENTIFY AND RECOGNIZE DEPRESSION AS AN OCCUPATIONAL DISABILITY CAUSE IN THE WORLD

The National Human Rights Commission (CNDH) points out that the State's responsibility to

ensure, respect and protect the right to health includes the essential international standards and that it is interrelated with availability, accessibility, acceptability and quality in order to provide a physical mental and social wellbeing, and not only the absence of disease or illness.

In occasion of the World Day Health-April 7-, we are all celebrating the measurements to attend the depression, which is the first cause of occupational disability in the world- according to the World Health Organization (OMS). In Mexico, it affects almost 10 million of people, fifth of those develop chronic stages that without treatment could derive into self-destruction, addictions and suicide.

According to the national epidemiological survey, Mexico is one of the countries with the major prevalence of clinical patients reported. Our health laws and policies are insufficient to detect it in time and to diagnose appropriately the population affected by it. This National Commission likewise warns upon de need to identify and recognize depression as a factor that motivates occupational disability.



The cities that will suffer the major damages because of the rise of the sea level by 2050

Researches of the Basque Centre for Climate Change (BC3), insisted to take urgent action before the risks of flooding because of the rise of the sea level, caused by extreme climates phenomena in 120 big coastal cities of Southeast Asia, United States west coast and Oriental Africa between 2030 and 2100.

The table of cities that will suffer worst damages by coastal flooding consequences in 2050, is headed by the Chinese city of Guangzhou, according to the team conclusions that were published in the recognized American scientific magazine Environmental Research Letters (ERL)

New Orleans, in the United States, occupies the second place in this list, even to the fact that its protection against a sea level rise is bigger than the China's metropolis. A great number of cities of the Southeast Asia occupy the first positions of the table on important material damages, such as

Bangkok (Thailand capital city) and other Indian cities as Bombay and Calcutta in third, fourth and fifth place, respectively.
