THE PRESIDENT'S VOICE

Message from the President of the CNDH on the commemoration of March 8 *"International Women `s Day"*

Good afternoon to all. On this emblematic date, not only for all women but also for men, this new CNDH, conscious of its constitutional mission, has the commitment to influence the construction of an inclusive democratic society, and to combat the historical inequalities we have faced, the greatest of human rights violations that people can suffer.

This day would not be possible without understanding the historical context of the multiple struggles that allow us to be here today, with greater rights than those we had decades and centuries ago. It would not be understood without the historic marches or strikes of working women not only in New York, but in different parts of the world, and certainly here in Mexico.

Women proclaimed the beginning of an ethical, political and ideological movement that would lead them to the construction of that scaffolding of rights, such as the right to be considered human beings and citizens, to a decent job, to women's suffrage, that is, to be able to vote, to be elected, and nowadays, to achieve a good life.

Thanks to all this background, the role of women in the decision-making process in our country has been strengthened and the inequality gaps have been narrowing. Today, in the federal Executive Branch, women have greater participation thanks to the fact that gender parity in the cabinet is a fact; likewise, the Supreme Court of Justice of the Nation, the Bank of Mexico, the Congress of the Union and this CNDH are headed by women, and our presence is advancing towards other spaces of power.

This year, in which two women are presidential candidates, it is essential to make human rights visible in the context of the exercise of political-electoral rights and to assume greater commitments to accelerate substantive equality, so that the electoral and jurisdictional authorities analyze the context of women in all areas of their lives, in their families and in relation to their communities, adopting temporary measures that they consider most appropriate to accelerate this equality.

In the pronouncement on political violence in Mexico, precisely these gender inequalities are made visible and various guiding criteria are formulated,

among them the one contained in the recommendation "THIRTEENTH. In the case of women, the application of temporary

special measures has the objective, as in all other cases, of accelerating the achievement of substantive or de facto equality of women in particular, for which reason the electoral and jurisdictional authorities should analyze the context of the situation of women [...]".

To this end, this CNDH, as has been stated in different pronouncements, has created a mechanism that is carrying out the monitoring that observes the behavior of political actors and to be able to prevent political violence against women.

For this Commission it is important to close gender gaps, combating and eradicating the different forms of violence, promoting equality and access to a life free of violence, to the free development of personality, to sexual and reproductive rights, to political participation, as well as to economic, social, cultural and environmental rights, to which the CNDH assumes its commitment without hesitation.

We live in a historically crucial time. We are in the midst of a process that will definitely change the course of Mexico, and the role of women in our society. We are on the threshold of a new era, in which women will not only be part of the productive forces, but we will also be the ones who will lead this nation towards horizons that our mothers and grandmothers imagined, which seemed impossible. Thanks to them, thanks to their tenacious struggle and determined participation in the public life of the country, they are about to become a reality. Today, we are being part of this transformation and it is up to us to pass it on to our daughters and granddaughters.

None of the conquests won by women have been fortuitous. On the contrary, each achievement, each right obtained, is based on the rebelliousness of women who have raised their voices against the oppression of the economic and political systems. With courage and determination we have defied the norms imposed by the morality of each era and have overturned the gender roles that limited us.

For many years we have faced political violence, and one of its manifestations, gender-based political violence, which is why the road to full equality is a challenge today. The possible arrival of a woman as head of the federal Executive Branch will not be the culmination of our struggle, but only the beginning of a new stage, and this obliges us to be attentive so that the change in power also means the radical transformation of State institutions, which will allow us to combat and eradicate each and every form of violence, especially those that impede the free development of women at every stage of their lives.

We women who have achieved positions that have an impact on the transformation of public life have a unique responsibility: to promote the conquest of new territories and ensure that no woman is left behind. Above all, we cannot allow ourselves to be complacent with the normalization of violence, in any of the spheres of the public or private sphere, against other women or girls, or against any person, and much less, to be permissive or permissive in the worst of violence, poverty and inequality, which threaten the dignity and integrity of every human being.

I speak of all human beings because it is fundamental that our struggle be inclusive, women and men alike, and that no one be discriminated against because of their identity, appearance, ideology or way of thinking, nor because of their economic or social condition, nor because of their preferences and orientations. The struggle of women, the one that unites them with men and with all the people, is the struggle for equality, and precisely because of this, today more than ever we must remain united, all of us, to safeguard our political, social, economic and cultural rights, and remember that we continue to fight for an egalitarian world, free of violence and discrimination, so that we can all enjoy an equal life, with the opportunities and rights we deserve, in a prosperous and safe world, with full respect for human rights.

Finally, I would like to emphasize that it is through these days that we commit ourselves to continue promoting equality between women and men, a true democratic and humanist society. This is a commitment that we assume with determination and solidarity, with the aim of building a fairer and more egalitarian world in the political, social, cultural, educational and economic spheres, I insist, I emphasize, for all men and women.

During the commemoration of March 8, International Women's Day, the National Human Rights Commission (CNDH) once again assumed its commitment to influence the construction of an inclusive democratic society, combat inequality and human rights violations.

On March 8, 2024 and as part of the beginning of the commemorative days of International Women's Day, the CNDH held an inaugural ceremony in the auditorium of the National Center for Human Rights (CENADEH). The event was headed by President Rosario Piedra Ibarra, who highlighted the importance of this commemoration, not only for all women, but also for men.

During her participation, the head of this National Commission recalled the historical struggle undertaken by women who stood up against the oppression of the economic, social and political systems. Thanks to their tenacity, she emphasized, it is possible to have a better historical context about the multiple battles that today allow women to be visible and exercise rights that they did not have decades ago, and that would not

be understood without the historic marches or strikes of working women not only in New York, but also in different parts of the world, and of course here in Mexico.

She also pointed out that today our country is living in a different environment, where two women are presidential candidates, which is why it is essential to make human rights visible in the context of the exercise of political-electoral rights and to assume greater commitments to accelerate substantive equality.

She also mentioned that the possible arrival of a woman as head of the federal Executive Branch will not be the culmination of women's struggle, but rather the beginning of a new stage that obliges us to be attentive so that the change in power means the transformation of State institutions, and in this way combat and eradicate each and every form of gender violence.

Therefore, it is essential that the electoral and jurisdictional authorities analyze the context of women in all areas, in order to adopt appropriate measures to accelerate this equality and thus close the gender gaps by combating and eradicating the various forms of violence, promoting equality and access to a life free of violence, free development of personality, sexual and reproductive rights, political participation and economic, social, cultural and environmental rights (DESCA).

At the end of the opening ceremony of the commemoration, the President of the National Commission toured the art exhibition on display at the CENADEH facilities, which addresses the human rights, life and contributions of women to society.

On March 14, 2024, the National Human Rights Commission (CNDH) held a discussion on Gender Gap in the World of Work as part of International Women's Day. It was led by María del Carmen Ojesto, Director General of the Sixth Inspector General's Office, who was also in charge of welcoming the participants.

The director expressed her satisfaction with this type of exercise, as it is part of the new vision of the CNDH and of human rights. where the victims of human rights violations are placed at the center of the activities, who, she added, have the right to an extraordinary guality of life, to live well. In this sense, healthy labor relations make it possible to achieve a life full of satisfaction, not only economically, but also personally, and for this reason it is important to emphasize that human rights are collective; that is, they imply the right of the collective to live well, to think that recognizing and protecting them has repercussions on the well-being of the community.

In her speech, Verónica Caporal Pérez, deputy director of Projects and Resolutions at the Sixth Inspector General's Office, recalled part of the struggles of women for the recognition of their rights, as well as the construction of these rights: "We organized ourselves in an ethical, political, ideological movement, which means that we speak of a feminist ethic, we speak of a political positioning and we have a way of thinking: the construction of a knowledge that will lead us to the foundation of a scaffolding of individual faculties and liberties that were born from the collective, but will have an impact on the individual, such as the right to be considered citizens, to a decent job, to women's suffrage, all this is only achieved through the recognition of economic, social, cultural and environmental rights".

She also pointed out that many women do not have economic remuneration because they are employed in informal jobs that offer them more flexibility to fulfill family and child-rearing roles, although it places them in positions of inequality and vulnerability,

without access to social security or a childcare system.

In this sense, the current management of the CNDH has issued several recommendations and in some cases special reports, which constitute valuable information on specific problems related to the recognition of the right to decent work for women; this as part of the process of resignification and construction of a new critical thinking of human rights. It is worth noting that most of the recommendations were issued for sexual harassment, harassment at work, discrimination, and dismissal due to pregnancy.

Thus, this type of event helps to counteract such violence, in large part thanks to the contributions of the participants, which, in turn, can be the origin of better public policies that contribute to the protection of human rights with a gender vision.

Panel humanitarian Crisis in Gaza

In order to analyze what is happening in Palestine and its repercussions worldwide, on March 15 the National Human Rights Commission (CNDH) organized the panel Humanitarian crisis in Gaza. The urgency of the return to the human. This event was held at the National Human Rights Center "Rosario Ibarra de Piedra", and was headed by Rosy Laura Castellanos Mariano, general director of the Center.

Several specialists in the field participated: Ammar Al-Dwaik, from the Palestinian Independent Commission for Human Rights; José Luis Michelena, executive director of Doctors without Borders; Alejandra Gómez Colorado, executive director of the National Museum of Cultures; Diego Gómez Pickering, from the Mexican Council for International Affairs (COMEXI), as well as CNDH staff.

One of the issues discussed at the event was the escalation of violence in the Gaza Strip, which currently involves the violation of several human rights and has led to the destruction of 80% of the territory. It should be recalled that Gaza was already suffering from a blockade by sky, sea and land imposed by Israel since 2006, and has been home to hundreds of refugees on its own land since 1948, so that the bombardment suffered by the Palestinian civilian population has taken unimaginable scales and represents a serious setback in terms of human rights.

In this regard, during the panel, the participants agreed that the number of civilians who have lost their lives during this military attack is extremely worrying, since the number of victims of bombings exceeds 35,500 people, in addition to the fact that there have been almost 2 million displaced persons.

According to the Palestinian Independent Commission for Human Rights, during this military attack 70,000 tons of explosives have fallen on the territory of Gaza, which is why it is estimated that 150 people die every day, in addition to the fact that the main victims are women and children.

Therefore, the CNDH considers it necessary to guarantee the protection of the rights of

Palestinian children and adolescents -especially Gazan children, who are highly stigmatized and violated- including their rights to education, health and a safe and violence-free environment, and to develop their life project.

José Luis Michelena, executive director of Doctors Without Borders, pointed out that the health system is in poor condition and can no longer respond to the needs of the population: of the 36 hospitals in Gaza, only 8 are in operation, and with extreme shortages, given that there is no power, no gas for medical equipment, and no fuel for ambulances.

In this sense, the National Human Rights Commission has insisted on the need to resume the path of a peaceful solution, since a dialogue between Israel and the Palestinian people is necessary; a dialogue that allows finding solutions to a complex problem, and that appeals to the highest and noblest of human feelings on the part of all those involved.

In addition to the above, it is essential that the international community and multilateral organizations assume their responsibility, and that the recognition of the existence of the Palestinian State is not left aside.

HUMAN RIGHTS IN THE WORD

Ombudsman Offices

The purpose of this section is to report on the activities, actions or positions of the various ombudspersons around the world. Based on the international context, we offer an analysis of initiatives, laws or reports carried out in different countries, in order to observe regional coincidences that add valuable contributions to the defense and protection of human rights.

During the course of March, two trends were observed regarding women's rights and the actions undertaken by human rights ombudsmen's offices. In the context of International Women's Day, the Brazilian Ombudsman's Office presented the Observatory on Violence against Women, an innovative measure to analyze the structural inequality faced by Brazilian women in the economic, political and educational spheres. The project could represent the starting point for the elaboration of public policies aimed at eliminating discrimination and social and cultural barriers.

On the other hand, there were several actions carried out by the ombudsmen's offices of Brazil, Uruguay, Panama and Peru, which addressed the rights to due process, political-electoral rights and access to health. It is worth noting that the Brazilian Ombudsman's Office established that people in the context of mobility should have access to the right to health, thus recognizing equality for the national and foreign population in this area.

The Economic Commission for Latin America and the Caribbean (ECLAC) and UN Women presented the document The 2030 Agenda for Sustainable Development and the Regional Gender Agenda in Latin America and the Caribbean. Gender Indicators to 2023. The purpose is to provide a reference report to promote decision-making in order to achieve equality and the full exercise of the rights of women, adolescents and girls.

BOLIVIA

The nomination of candidates must be free and without discrimination. Aware of this, the Ombudsman's Office acknowledged the decision of the Superior Electoral Tribunal (TSE) to require the distribution of economic resources for indigenous candidacies registered by political parties, thus strengthening the democratic environment and vindicating the cultural identity of such candidacies.

In this sense, the Ombudsman's Office established that people in the context of mobility should be included in the list of organ transplants, thus guaranteeing their access to the right to health.

Recommendations

During March, the National Human Rights Commission issued 25 recommendations; 24 ordinary and one for serious human rights violations.

Regarding the ordinary recommendations, 11 were issued to the Mexican Social Security Institute due to the fact that this agency violated several human rights: to health, to life, to access to health information, to personal integrity, to a life free of obstetric violence, to the best interest of the child, to dignified treatment and to a life project.

Regarding serious violations, the recommendation issued by this National Commission was for the governor of the state of Querétaro, the attorney general of the same entity, the municipal president of Pedro Escobedo, Querétaro, the municipal president of Huimilpan, Querétaro, and the municipal president of El Marqués, Querétaro. This was for serious violations of the human rights to freedom, legality, legal security, integrity and personal safety.

Actions of unconstitutionality

The Political Constitution of the United Mexican States establishes that the National Human Rights Commission has standing to sue, before the Supreme Court of Justice of the Nation, the invalidity of laws that are issued or reformed and that are considered to violate human rights. Once the law is published in the official media in question, the National Commission has a term of thirty calendar days to challenge the norms that are deemed to violate fundamental rights.

In this sense, during this month, 9 actions of unconstitutionality were approved, filed due to infringement of the right to legal certainty, equality and non-discrimination; legal certainty, prior judicial authorization or control and the principle of legality; the principles of taxation applicable to administrative sanctioning matters, tax proportionality and legality, the principle of constitutional supremacy and legality, among others.

Pronouncements

The CNDH published 3 statements during the month, in which it expresses its concern for the humanitarian crisis in Gaza, which has caused the death of many children, as well as a famine caused by the blockade imposed by Israel on the entry of foodstuffs. It also states that this Commission will not be a factor of confusion or contribute to the strategy of those who wish to cast doubt on the impartiality of the current electoral process. Finally, it respectfully calls on the Congress of the Union to comply with the third transitory article regarding the right to access to water and sanitation.

Press Releases

This month 22 communiqués were published, among which three stand out. In Communiqué 103/2024, the CNDH states that it initiated an ex officio investigation into the death of a student from the "Raúl Isidro Burgos" Rural Normal School. In Communiqué 108/2024, it denounces that it is under siege for issuing its report on political violence, since it received two summons from the National Electoral Institute (INE) and the Electoral Tribunal of the Judiciary of the Federation (TEPJF) derived from two complaints from the National Action Party (PAN), which seek to question its mission as the highest human rights protection body in the country. Finally, in Communiqué 113/2024, it welcomes the signing of an agreement with the National Commission of Medical Arbitration (CONAMED) with the objective of homologating and sharing criteria aimed at providing better attention to the population, and generating routes to resolve the contexts where human rights violations occur, specifically to the right to health.

RECOMMENDATIONS



ON THE PERSISTENCE OF VIOLATIONS OF THE HUMAN RIGHT TO A HEALTHY ENVIRONMENT, TO ACCESS TO DRINKING WATER AND TO HEALTH

The CNDH issued a recommendation to the heads of the Ministry of the Environment and Natural Resources, the National Water Commission, among others, after violations of the right to a healthy environment, access to drinking water, and the health of the inhabitants living in the Sonora River basin. The CNDH recommended that they issue a circular in which, in order to prevent human rights violations, they inform, within the framework of their respective competencies, about the obligation to verify the legality, validity and particular characteristics of the mining concessions; in addition, they should initiate the necessary steps for collective environmental reparations. Finally, it was recommended that a training course be given to address the violated rights.

ECOMMENDATION

15

REGARDING THE APPEAL AGAINST THE AGREEMENT OF CONCLUSION OF THE FILE INTEGRATED BY THE HUMAN RIGHTS COMMISSION OF THE STATE OF MEXICO, FOR THE VIOLATION OF THE HUMAN RIGHTS TO LEGAL SECURITY AND LEGALITY

The CNDH sent a recommendation to Myrna Araceli García Morón, president of the Human Rights Commission of the State of Mexico, and to Jose Luis Cervantes Martinez, attorney general of the State of Mexico. The CNDH recommended that they reopen the complaint file, inform the authorities, and train the personnel in charge of the complaint files on issues related to possible acts of torture. It also requested that they give courses for the investigation of the crime of torture and issue a circular for the personnel to comply with national and international human rights norms.

REGARDING VIOLATIONS OF THE HUMAN RIGHTS TO THE PROTECTION OF HEALTH AND LIFE, AS WELL AS ACCESS TO HEALTH INFORMATION

The CNDH issued a recommendation to Zoé Alejandro Robledo Aburto, general director of the Mexican Social Security Institute (IMSS), after inadequate medical attention by the personnel. The CNDH recommended that they collaborate to register the victims in the National Registry of Victims and provide them with psychological and/or thanatological care if required. In addition, they should provide a training course on human rights related to the right to health protection. It also recommended that they issue a circular addressed to the personnel, with topics on the protection of health, life and access to health information.

RECOMMENDATION

ON VIOLATIONS OF THE HUMAN RIGHTS TO LEGAL SECURITY, DIGNIFIED TREATMENT AND THE BEST INTERESTS OF THE CHILD

The CNDH sent a recommendation to Francisco Garduño Yáñez, commissioner of the National Migration Institute, after human rights violations were committed by public servants of this institute. The CNDH requested that they collaborate in order to register the victims in the National Registry of Victims, and issue a circular instructing public servants that their actions must adhere to the provisions of the Guide for the Care of Migrant Children and Adolescents. In addition, it recommended that they give a training course on human rights related to the rights to legal security, dignified treatment and the best interests of the child; and requested that they issue a circular directed to the personnel so that in all the migratory procedures they initiate, they guarantee the right to legal security of the migrants.

The CNDH issued a recommendation to Francisco Garduño Yáñez, commissioner of the National Migration Institute, after human rights violations were committed by public servants of that institute. In addition, it requested that they issue a circular in order to avoid setting up any place or stay that does not comply with the Norms for Operation, and that they issue an action protocol for the INM personnel, with the objective of establishing principles attached to legality, legal security and dignified treatment.

REGARDING VIOLATIONS OF THE HUMAN RIGHTS TO LEGAL SECURITY, DUE PROCESS AND LEGALITY

The CNDH sent a recommendation to Francisco Garduño Yáñez, commissioner of the National Migration Institute, after human rights violations were committed by public servants of this institute. The CNDH recommended that they collaborate to register the victims in the National Registry of Victims; that they give a training course on human rights regarding the right to legal security, due process and legality of foreigners, and that they issue a circular addressed to public servants, so that they carry out their work in accordance with the applicable regulations, guaranteeing legal security, due process and legality.

It also recommended that they provide training courses on human rights and the observance of the best interests of the child.

It also requested them to provide a training course on human rights, related to the rights to the protection of health and life; and to evaluate the requirements of equipment, infrastructure, supplies and technological medical devices necessary to provide care to persons deprived of their liberty.

ON THE CASE OF SERIOUS VIOLATIONS OF THE HUMAN RIGHTS TO LIBERTY, LEGALITY, LEGAL SECURITY, INTEGRITY AND PERSONAL SECURITY

The CNDH sent a recommendation to the governor of the state of Queretaro, the attorney general of Queretaro, the municipal president of Pedro Escobedo, Queretaro, the municipal president of Huimilpan, Queretaro, and the municipal president of El Marqués, Queretaro. The CNDH recommended that they collaborate to register the victims in the National Registry of Victims and provide them with the necessary psychological care. It also requested that they offer a public apology to the victims and their families for the serious human rights violations; and that they provide a human rights training course on specific topics on the prevention and eradication of torture and other cruel, inhuman or degrading treatment or punishment, arbitrary detentions and the use of force in the context of demonstrations.

ACTIONS OF UNCONSTITUTIONALITY

UNCONSTITUTIONALITY ACTIONS FILED DURING MARCH 2024

During March of this year, the National Human Rights Commission located in the official media, both federal and local, the publication of 202 issuances, additions and/or modifications of legal ordinances. In this month, said Commission filed 9 lawsuits of unconstitutionality action, through which 32 general norms were challenged.

- » On March 11, 2024, an action of unconstitutionality 64/2024 was filed before the SCJN, filed against 6 municipal income laws of the state of Oaxaca for the fiscal year 2024. The aforementioned, upon appreciating that the rights to legal certainty, equality and non-discrimination, principles of taxation applicable to administrative sanctioning matters, tax proportionality and legality are violated.
- » On March 13, 2024, an action of unconstitutionality 67/2024 was filed before the SCJN, filed against Article 33 BIS, last paragraph of the Organic Law of the Attorney General's Office of the State of Nuevo Leon, considering that it violates the rights to legal certainty, to prior judicial authorization or control and the principle of legality.
- » On March 19, 2024, an action of unconstitutionality 69/2024 was filed before the SCJN against eleven municipal income laws of the State of Oaxaca for the fiscal year 2024. The aforementioned, considering that they infringe the rights to legal certainty,



equality and non-discrimination; principles of taxation applicable to administrative sanctioning matters, tax proportionality and legality.

» On March 22, 2024, a petition of unconstitutionality action 71/2024 was filed before the SCJN, filed against articles 17, section VI, in the normative portion "broad moral solvency and of", and 29, section III, in the normative portion "and of broad moral solvency", of the Organic Law of the Intercultural University of Jalisco; upon assessing that it violates the right of legal certainty and principle of legality.

- » On March 22, 2024, an action of unconstitutionality 72/2024 was filed before the SCJN, filed against articles 17, section III, in the normative portion "from 14 to 29 years of age", and 114, in the normative portion "and the Federal Law of Responsibilities of Public Servants", of Law Number 688 of Young Persons of the State of Guerrero; since it violates the right to legal certainty; principle of constitutional supremacy and legality.
- » On March 26, 2024, a petition of unconstitutionality action 75/2024 was filed before the SCJN against the nine municipal income laws of the state of Oaxaca for the fiscal year 2024, because the rights to legal certainty are violated; principles of taxation applicable to administrative sanctioning matters, tax proportionality, and legality.
- On March 26, 2024, an action of » unconstitutionality 76/2024 was filed before the SCJN, filed against Articles 97, last paragraph, 100, 101, in the regulatory portion "or definitively", 102, 106, in the regulatory portion "and National Code of Criminal Procedures", 169, 170, 171, 172, 173, 194, first paragraph, in the normative portion "the certificates or certified copies in sheets of greater dimension or greater number of lines will cause double fee", 223, sections I and II, paragraphs a), b) and c), 245, penultimate paragraph, 271, section IV, and 366, second paragraph of the Tax Code Number 726 for the Municipality of Tlalixcoyan, State of Veracruz de Ignacio de la Llave; because they violate the rights to equality and nondiscrimination, to access to public office, to legal security; principles of proportionality in contributions,

of exact application of the criminal law, of proportionality of penalties, of presumption of innocence, of guilt in criminal matters and of legality.

- On March 26, 2024, an action of » unconstitutionality 77/2024 was filed before the SCJN, filed against articles 13, second, third, fourth and fifth paragraphs; 14, first paragraphs, paragraphs a) and b), as well as second and fourth, in the normative portion "Compensation will be made in accordance with paragraph a) of this article", 15, second paragraph, and 16 of Law Number 466 of Patrimonial Responsibility of the State of Guerrero and Municipalities. The foregoing, due to the fact that the rights of access to justice, full reparation of the damage and fair compensation are infringed.
- » On March 26, 2024, an action of unconstitutionality 78/2024 was filed before the SCJN, filed against article 457, section V, of the Family Code for the Free and Sovereign State of Morelos; since the rights to privacy and private life, to the freedom to form a family, to human dignity in its aspect of free development of the personality, prohibition of arbitrary interference and the obligation to respect, promote, protect and guarantee human rights are not complied with.

PRONOUNCEMENT 07/2024 STATEMENT ON THE HUMANITARIAN CRISIS IN GAZA

In the global human rights panorama, a case that requires urgent international support is the critical situation in Gaza, due to the escalation of violence that has resulted in the destruction of 80% of that territory since October 7. The number of civilians killed by bombardments exceeds 30,650 people, and according to the Palestinian Independent Commission for Human Rights, since October 2023, 70,000 tons of explosives have fallen; it is estimated, therefore, that 150 people die every day, where the main victims are women and children.

In addition to the threat of war and insecurity, a famine persists which is not caused by natural conditions, but by the blockade imposed by the State of Israel on the entry of food and humanitarian aid. As if that were not enough, the health system is in a deficient condition to respond to the most affected population.

Therefore, we are dismayed by the failure of the United Nations Security Council; however, we insist on believing in the importance of considering the framework for the protection of human rights and we make an urgent appeal to the international community to respect and promote international human rights law and international humanitarian law. We also consider it necessary to guarantee the protection of the rights of Palestinian children and adolescents.

PRONOUNCEMENT 08/2024

THE CNDH WILL NOT BE A FACTOR OF CONFUSION NOR WILL IT CONTRIBUTE TO THE STRATEGY OF THOSE WHO WANT TO QUESTION THE IMPARTIALITY OF THE CURRENT ELECTORAL PROCESS; THEREFORE, IT WILL SUSPEND THE ISSUANCE OF ITS REPORTS ON POLITICAL VIOLENCE

The National Human Rights Commission (CNDH) created the National Mechanism for the Observation and Protection of the Right to Democracy in the 2024 Electoral Process, and issued two reports on political violence with the purpose of protecting and defending the right to democracy. However, an unnecessary debate has been opened that distances this National Commission from the objectives for which it conceived the Mechanism in charge of elaborating the reports, for which reason, after reflecting on the context we live in, the CNDH has decided to suspend the issuance of these reports.

We consider that neither the role nor the attributions of the CNDH should be at the center of attention, especially if they distract citizens from what is fundamental, which is to analyze the candidates and their proposals, so that they can choose freely. The CNDH reaffirms its commitment to the defense of the people's right to democracy, and will be attentive to what happens within the framework of the electoral process we are living.

PRONOUNCEMENT 09/2024 THE CNDH MAKES A RESPECTFUL CALL TO THE CONGRESS OF THE UNION TO COMPLY WITH THE THIRD TRANSITORY ARTICLE REGARDING THE RIGHT TO ACCESS TO WATER AND SANITATION

On the occasion of the commemoration of World Water Day, the National Human Rights Commission (CNDH) assumes its commitment to the defense of the country's water resources, and therefore makes a respectful call to the members of the Congress of the Union to comply with the third transitory article of the Decree that incorporated the recognition of the right to access to water and sanitation, and to issue the corresponding General Law.

This National Commission has documented various problems in the area of water and sanitation that have been reflected in at least 18 recommendations. In this sense, to ensure the provision of water it is essential to guarantee and respect human rights obligations, such as freedom of expression on water issues, water education and culture, public access to information on water, civil society participation in water decisionmaking, and protection for water rights defenders.

For the CNDH, it is essential to address the problems arising from possible violations of the human right to water and sanitation, since unequal access to water, its contamination or scarcity put social stability and peace at risk.

PRONOUNCEMENT 10/2024 THE CNDH DOES NOT ACCEPT THAT THEY ARE TRYING TO MUZZLE IT WITH REGRESSIVE INTERPRETATIONS OF ITS CONSTITUTIONAL MISSION TO FAVOR A POLITICAL PARTY; IT WILL INITIATE ACTIONS TO SAFEGUARD ITS RIGHT TO DEFEND THE RIGHTS OF THE PEOPLE

The National Human Rights Commission (CNDH) has been notified of the complaint filed by the National Action Party (PAN), which declares "invalid" and "without any legal effect" the establishment of the mechanism to observe electoral campaigns and its reports on political violence. The above constitutes a regressive interpretation that contradicts the block of constitutionality that has governed us since 2011, and a threat against the right to defend the rights of the people, a mission assigned to the CNDH by our current Political Constitution.

The CNDH at no time has been constituted as an electoral authority, what this Autonomous Organism sought, through its two Reports on political violence, was to make visible and alert about the terrible and profound consequences that violence can cause to the exercise of the political-electoral rights of Mexicans in the context of campaigns.

This National Commission is fully prepared to contribute its support for an exemplary exercise of the right to democracy. We respectfully invite the electoral authorities, the ministers of the TEPJF, to build bridges of dialogue and unite around what we have in common: the commitment to work in the interest of all Mexicans.

103/2024 THE CNDH INITIATES AN EX OFFICIO INVESTIGATION INTO THE UNFORTUNATE DEATH OF A STUDENT FROM THE RURAL NORMAL SCHOOL "RAÚL ISIDRO BURGOS"

The National Human Rights Commission (CNDH) initiated an ex officio complaint on the occasion of the regrettable events that occurred on March 7, 2024, in which a student of the Rural Normal School "Raúl Isidro Burgos" of Ayotzinapa lost his life and another was injured, at a state police car checkpoint.

This National Commission will initiate an ex officio investigation and will compile the corresponding file, for which reason it will request the necessary reports from the various authorities, with the objective of clarifying the facts. If necessary, this Commission will report on the alleged human rights violation.

The CNDH sends its condolences to the relatives of the deceased, and will remain attentive to the ministerial investigations in order to guarantee full clarification of the facts, access to justice and the truth of these unfortunate events.

108/2024 THE CNDH IS UNDER SIEGE FOR ISSUING ITS REPORT ON POLITICAL VIOLENCE; IT RESPONDS TO DEMANDS FROM THE NATIONAL ACTION PARTY BEFORE THE INE AND THE TEPJF

The National Human Rights Commission (CNDH) received two demands from the National Electoral Institute (INE) and the Electoral Tribunal of the Judiciary of the Federation (TEPJF) derived from two complaints from the National Action Party (PAN), which seek to question its mission as the highest human rights protection body in the country.

The central argument is that, with the issuance of its Report on Political Violence for the Protection and Defense of the Right to Democracy, this CNDH is interfering in the electoral process, however, as it has been clarified, the creation of the National Mechanism for the Observation and Protection of the Right to Democracy does not seek in the least to influence the decisions of the electoral authorities, much less to guide the vote. On the contrary, the issuance of these reports is in strict compliance with our constitutional mission to promote, protect and defend rights, among them, political-electoral rights.

This National Commission issues a forceful and firm call for attention in the face of attempts to eliminate their voice, especially when we live in a context that demands, from all authorities, parties and candidates, the greatest commitment to human rights.

113/2024 THE CNDH AND CONAMED SIGN AGREEMENT TO PREVENT AND ADDRESS VIOLATIONS OF THE HUMAN RIGHT TO HEALTH PROTECTION

The National Human Rights Commission (CNDH) and the National Commission of Medical Arbitration (CONAMED), with the presence as witness of honor of Dr. Froylan Enciso, head of the Human Rights Defense Unit of the Ministry of the Interior, signed a collaboration agreement whose purpose is to standardize and share guidance criteria aimed at providing better care to the population, generate routes to resolve the contexts where human rights violations occur, specifically to the right to health, and prevent such violations.

In this sense, the president of the CNDH, Rosario Piedra Ibarra, highlighted the unprecedented effort to defend the human right to health, at a time when the country has experienced great changes, and expressed her confidence that this agreement will serve and bear fruit in the promotion of a culture of respect and prevention of the right to health, essential for being part of the economic, social and cultural rights that were so much denied to our society in the past three decades.

For his part, Dr. Enciso highlighted the excellence of the resources available to CONAMED, which can provide, objectively and scientifically, all the arguments to the CNDH and the Mexican government itself "not only for the follow-up of complaints or recommendations, but also for the prevention of human rights violations; an objective shared by the Fourth Transformation". He also pointed out that for the current government, all its actions are aimed at advancing human rights, without waiting for the omissions and errors of public servants to be pointed out, so that the people of Mexico do not have to file a complaint, but receive the quality medical services they deserve.
